Veterinarian certificate for bitches in season or injured dogs.

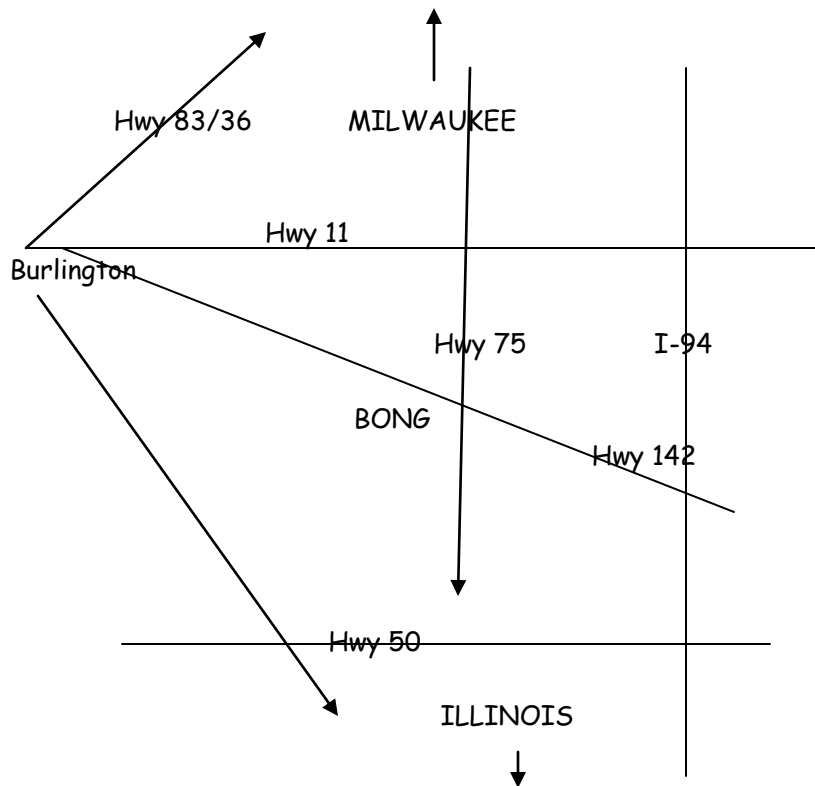

Bong Recreational Area is a 7 square mile area located in Southeastern Wisconsin approximately 15 miles west of Kenosha, WI. The following is a map to the area. This is run by the Department of Natural Resources of the State of Wisconsin and a daily entrance fee is charged, unless you have an annual park permit either as a resident or nonresident of Wisconsin.

We wish to remind exhibitors that there will be no food available on the grounds. Bring your own food, drink and water for your dog. Also please remove your own waste the day of the test as there is no dumpsters available. The closest food facilities are in Burlington, WI approximately 7 miles west of Bong.

Please remember that there is no training on the grounds the day of the test, and that you are responsible for cleaning after your dog.
