Bitches in season will not be allowed to run the test. A refund of entry fee will be made with a Veterinarian certificate for bitches in season or injured dogs

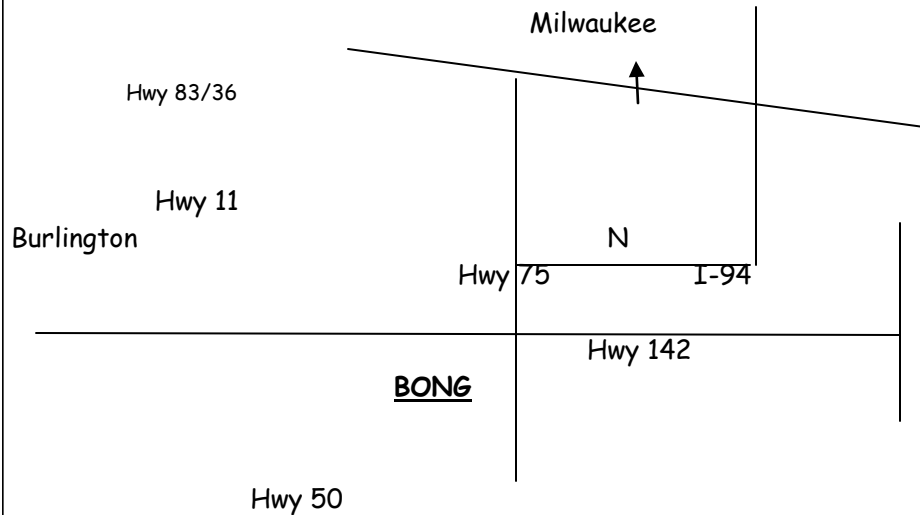
