WISCONSIN DEPARTMENT OF AGRICULTURE RULE ENACTED IN 1954.

No person shall import a dog over six months of age into this state unless it is accompanied by an interstate health certificate including thereon a report vaccination for rabies. Such vaccination shall be conducted not more than 12 months prior to entry. Provided that when chick embryo vaccination is used, each vaccination shall be conducted not more than 36 months prior to entry. An interstate health certificate shall be executed by a veterinarian of the state of origin showing animals identified thereon have been inspected and no infectious diseases disclosed, and to include a rabies report.

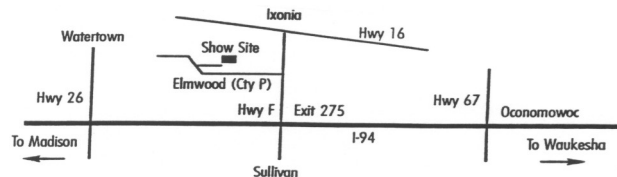

The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
