ENTRY FEE: \$30.00 Entry fee for the first entry
\$20.00 Entry fee for the 2nd entry of the same dog
\$15.00 Entry fee for the 3rd entry of the same dog
Fees include \$0.50 AKC record fee plus \$3.00 service fee.
Fee of \$3.50 included for Rally entries.

NOTE: Rally is a separate trial and should be paid for as such.

Make all checks payable to BGRC. Canadian exhibitors must make funds payable in US funds. Exhibitors whose checks are returned for NSF will be assessed a \$20.00 service fee. Entries will not be accepted if received without signatures, fees and back of entry form with agreement. All official American Kennel Club entry form must be used. Telephone and telegraph entries cannot be accepted. No entry will be accepted which is made subject to conditions. **FAX ENTRIES WILL NOT BE ACCEPTED.**

Entries close at the Trial Secretary's home on **WEDNESDAY, October 2, 2024** unless the numerical limit is reached prior to the date after which time entries will not be accepted, cancelled, altered, or substituted.

PLEASE NOTE: If entry is sent via next day air service, UPS, DHL Express, Federal Express, Express Mail etc. Please indicate that **NO SIGNATURE is required** on arrival or entry may not be accepted in time. Secretary not required to retrieve entry from service.

BITCHES WHO COME INTO SEASON after the closing date will have the entry fee less \$5.00 refunded upon written certification by a licensed veterinarian to the effect that the bitch in question is in season on the day of the trial. Notification must be received by the Trial Secretary before 8:00 a.m. on the day of the trial.

ENTRY FEES SHALL NOT BE REFUNDED in the event that the dog is absent, disqualified, excused by a veterinarian or judges, or barred from competition by action of the Trial Committee. If, because of riots, civil disturbances, or other acts beyond control of the Trial giving Club, it is impossible to open or complete the Trial, no refund of entry fees will be made.

ENTRY FORM changes, additions or corrections MUST be received in writing or by email prior to the closing of entries. Those received by telephone are not acceptable.

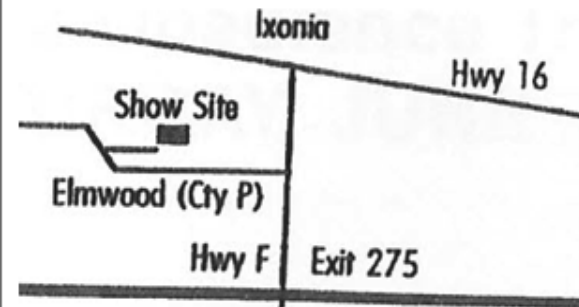
DIRECTIONS TO TRIAL SITE

From 1-94:

Exit 275 County F, Ixonia/Sullivan exit. Go North on F about 4 miles. Turn West (left) on Elmwood Dr. / County P Gust before train tracks). Turn East (right) on Cedar Dr.

From the East:

Take Hwy 16 (about 5 miles west of Oconomowoc). Turn South on County F. (Ixonia). Turn West (right) on Elmwood. Turn East (right) on Cedar Dr. The building is at the end of Cedar Dr.



EMAIL, TELEPHONE, FAX AND UNSIGNED ENTRIES WILL NOT BE ACCEPTED. ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS AND PHOTOCOPIES OF ENTRY FORMS that do not include the Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

The show-giving club and the show secretary assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property and further assume no responsibility for injury to children not under the control of their parents or guardians.

DOGS NEED TO BE PRESENT only at scheduled time of judging. Dogs not required for further judging will be excused.

CLASS PRIZES will be awarded in the ring to the person showing the dog. Claims for awards must be made in the ring before the judging of the next class is over and the Show Secretary advised at once. BGRC disclaims any liability for awards after the judging of the class is over. Prizes will not be mailed.

A CLASS TRANSFER will be allowed and may be requested if, according to the owner's records the handler and dog are eligible. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. Transfers prior to the day of the trial will be accepted and a WRITTEN request addressed to the Trial Secretary is required.

CATALOGS are available for preorder for \$4.00. Please check appropriate box on your entry form and enclose the required fee. Preordered catalogs are to be picked up at the trail. Preordered catalogs that are not picked up will NOT be mailed.

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
